Vitae:

Matej Savic was born in Banja Luka 1984, where he completed his primary and secondary education (social - language course, English and French). He graduated from the Faculty of Law of the University of Banja Luka in 2007. At the same faculty in the 2008-09 school year, he enrolled in post-graduate studies in the field of international legal science. During his studies he wrote two scientific papers (one published) and passed all the exams with an average grade of 10 (ten). He passed multiple master exam with distinction (cum laude). He defended his master's

thesis on 26th November 2011 on the subject: *Diplomatic and* Consular Law in the system of law in general, with honors, from which he received a Master of science diploma in International legal science (MAsci).

At the Faculty of Law of the University of Banja Luka, on 07th February 2015, Matej defended his doctoral dissertation under the title: Problems of the state legal personality in the contemporary challenges of international law, with honors, from which he has earned the degree of Doctor of Legal Sciences (PhD).

For several years he worked in PPGD Comesgrafika Banja Luka. After graduation he was employed at the National Assembly of the Republic of Srpska, first as an intern and then as an associate in the Committee on Constitutional Affairs, and by the end of 2008 as a Secretary of the Committee on Health, Labor and Social Policy. On 15th March 2009 he passed the professional exam for employees of the state administration. Since the 1st March 2011 he was employed at the University of Banja Luka, Faculty of Political Science, where he served as a teaching assistant on the subjects: Basics of Law, International Law, Political System of the European Union, and course of **Democracy and Human Rights.** He was secretary of the Political science Department from 2011 to 2013. He is a member of the Teaching - Scientific Council of the Faculty of Political Science, University of Banja Luka, from 2011 in front of the Political science Department. As of 2015 Matej is an assistant professor of International Law, and Diplomatic and Consular Law on the Faculty of Political Sciences in post-graduate program studies of International relations. Also, he is an assistant professor of **Theory of State and Law** on the undergraduate studies of Faculty of Political Science, University of Banja Luka.

Matej Savić is a member of the Association of Lawyers of the Republic of Srpska and Association of Serbia, and a member of Matica Srpska in Republic of Srpska. Also, he is a member of European Society of International Law (ESIL) He participated in several projects in the field of Development of Human Rights and current EU Integration. Matej is the author of more than fifteen scientific papers and many expert articles, and he is active in the social life of the Republic of Srpska. He participated in a number of scientific and expert conferences of national and international importance. He has published articles in several journals in Banja Luka, in the New Serbian Political Thought (NSPM) from Belgrade, and also journals from Croatia, and others. The current rate is Associate author for Novi polis Belgrade, Serbia. from January 2016.

In addition to his mother language, Serbian he actively speaks English and has elementary knowledge of French.

He is married, father of one.
